## **Dear Sisters and Brothers:**

It is with a great deal of sadness that we announce that the 150<sup>th</sup> Grand Session at Caesar's Casino and Hotel has been cancelled for this year. We are required to obey the NJ State guidelines, which currently restricts indoor gatherings to 25 or less people. Below is the official mandate from the Governor which can be found on the New Jersey State website:

## **Indoor Gatherings**

Face coverings are required in indoor public spaces and in outdoor public spaces when social distancing is difficult to maintain. **General indoor gatherings** must be limited to 25 people. All attendees at indoor gatherings must wear face coverings and stay six feet apart. *Last Updated:* 03/18/2021
